III. PERIOD OF CONTRACT APPOINTMENT:

- 1. The tenure of contract appointment will be initially for a period of 3 years and extendable based on performance of the employee and requirement of BMRCL.
- 2. The contract of appointment may be terminated by either side by giving 3 months' notice or by paying the contractual remuneration in lieu of notice period, if the circumstances so warrant.

IV. SELECTION PROCEDURE:

- 1. The selection will be made strictly based on the merit of GATE Score. Candidates should have a valid GATE score as on the date of Notification. Shortlisted candidates will be called for verification of the original documents and interview.
- 2. If equal GATE score is obtained by two or more candidates, then the score secured in the engineering degree will be taken into consideration for preparing the merit list.
- 3. The appointment of selected candidates is subject to final verification of educational qualification, age, and verification of antecedent/character of the candidate.
- 4. BMRCL reserves the right to conduct additional written examination / skill test / medical test / document verification at any stage. BMRCL also reserves the right to cancel part or whole of any recruitment process at any stage.
- 5. The application of any candidate found guilty of impersonation or submitting fabricated documents or making statements, which are false or incorrect or indulging in suppression of facts, attempting to use unfair means for the purpose of recruitment, will be liable for rejection.

V. GENERAL CONDITIONS:

- 1. Women candidates may note that duties in the Company may be arduous in nature and require working in the project site and during late hours.
- 2. Any subsequent changes in the terms and conditions of this Employment Notification as per extent rules will stand good. BMRCL reserves the right to consider/incorporate any subsequent changes/modifications/additions in the terms & conditions of recruitment under this Employment Notification as necessitated and applicable.
- Candidates should note that the Date of Birth as recorded in the Matriculation/High School
 Examination Certificate or equivalent Certificates as on the date of submission of applications will
 only be accepted.
- 4. Possession of essential educational qualification prescribed is must. The candidate should have scored minimum 60% marks in the essential educational qualification prescribed. The said 60% should be computed by averaging marks of all the years and in all papers in the entire Degree course i.e., total marks obtained in all years divided by maximum marks of all examinations. In case, instead of marks, Grades have been given, the middle figure of the range that the Grade covers should be taken as marks obtained for each subject and total percentage computed as per above prescribed procedure. Eg: If Grade 'A' range is 80-100, middle figure: 90 should be taken as marks obtained or as per the formula prescribed by the respective University. The Degree should be from an Institute/Organisation recognized by AICTE. Document of equivalence needs to be produced for verification when called for. If such document is not produced the candidate shall be disqualified irrespective of his/her position in the merit list prepared.
- 5. Candidates who have been shortlisted will only be called for document verification & Interview. The candidates will have to appear for document verification interview at their own cost.
- 6. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/appointment shall be a disqualification.

- 7. Any legal issues arising out of the Employment Notification shall fall within the legal jurisdiction of Bangalore Court/s.
- 8. Knowledge of Kannada in all the four attributes viz., reading, speaking, writing & understanding is compulsory. Those who do not have knowledge of Kannada will be disqualified irrespective of the marks scored in the GATE.

VI. PROCEDURE FOR SUBMITTING APPLICATION:

- 1. Candidates should fill in the application **on-line**, take a print out of the same and submit along with copies of all certificates in support of qualification prescribed for the post. Candidates who fail to send hard copy of the on-line application along with relevant documents will not be considered even though they have submitted application on-line
- 2. Documents in support of qualification and valid GATE Scorecard shall be sent along with the application. Non-submission of documents along with the application, will lead to rejection of application at any stage during the process of recruitment.
- 3. Candidates shall update GATE hall ticket number and marks scored in the space provided in the online application.
- 4. The number of vacancies indicated in this notification is provisional and may increase or decrease depending upon the actual need. BMRCL also reserves the right to cancel the notified vacancies at its discretion and such decision will be final and binding on all.
- 5. BMRCL reserves the right to assess fitness or otherwise of the candidates selected.
